Company's By-laws. All shareholders registered as such on August 3, 2015 shall be entitled to receive the payment of the interest on equity. TOTVS' shares will be traded "ex-interest on equity" as of August 04, 2015. The interest on equity will be paid on August 19, 2015, with no monetary readjustment from August 3, 2015 to August 19, 2015.

5.- CLOSING, DRAW-UP AND APPROVAL OF THE MINUTES: There being no further matters to discuss, the meeting was suspended to draw up these minutes, which were then read, approved and signed by all attending Board Members.
